**: MEMORANDUM :**

**SUBJECT : OFFER OF APPOINTMENT.**

The undersigned hereby offers Shri SANANTH KUMAR S a temporary post of Multi Tasking Staff in the office of the Regional Office, Directorate of Field Publicity, BANGALORE under the Ministry of Information and Broadcasting, in the scale pay PB-1 Rs.5200 - 20200 and Grade Pay Rs.1800/-. The appointee will also be entitled to draw dearness and other allowance at the rate admissible under and subject to the conditions laid down in the rules and orders governing the grant of such allowances in force from time to time.

4. The terms and conditions of appointment are as follows:

- i. The post will be purely on temporary basis and sanctioned up to 28.02.2015, but likely to continue indefinitely.
- ii. The appointment may be terminated at any time by a month's notice given by either side, viz., the appointee or the appointing authority, without assigning any reasons. The appointing authority however, reserves the right of terminating the expiry of the stipulated period of notice by making payment to him a sum equivalent to the pay and allowances for the period by unexpired portion thereof.
- iii. The headquarters of the MTS post at present will be at BANGALORE but the appointment carries with it the liability to serve in any part of India.
- iv. The candidate will be on trial/probation for a period of two years from the date of appointment, which may be extended or curtailed at the discretion of the appointing authority.
- v. Other condition of service will be governed by the relevant rules and orders in force from time to time.

5. The appointment will be further subject to: -


- (i) the production of a certificate of fitness from the competent medical authority, in the prescribed form (Annexure I).
- (ii) submission of a declaration in the prescribed form (Annexure II), and in the event of the candidate having more than one wife//husband living, of wife living, or being married to a person having more than one wife living, the appointment will be subject to his/her being exempted from the enforcement of the requirement in this behalf.
- (iii) On joining the post the candidate will be required to take an Oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect in FORM-I is enclosed.
- (iv) Production of the following original certificates is mandatory.

- (v) (a) Certificates of educational and other technical qualifications,
- (b) Certificate of age and,
- (c) Character certificates from two Gazetted officers of the Central/State Government.
- (d) If already employed, should produce a relieving order from the Present Employer
- (e) Caste Certificate if belongs to SC/OBC.

4. If any declaration given or information furnished by the candidate proves to be false, or if the candidate is found to have will fully suppressed any material information he/she will be liable for remove from service, and such other action as government may deem necessary.

5.
